1 Introduction

4 The purpose of the collection and processing of your personal data

The purpose of the collection and processing of the personal data is to provide you with all services of the website of flashboys.io. The personal data that may be used and is voluntarily provided by you to Flashboys in order to provide you with all services of the website of flashboys.io is listed in section 3 of this statement.

5 Your rights regarding to your personal data

According to privacy legislation and regulation you have several rights regarding to your personal data. Furthermore you will have to right to data portability and the right to lodge a complaint with a supervisory authority.
